PRODUCT WARRANTY INFORMATION

Albany Industries, Inc furniture is made to suit individual tastes and needs at a reasonable price. Please note the following limited warranty for details.

LIMITED WARRANTIES

The following Limited Warranties are given to the original purchaser of Albany Industries, Inc.

FRAMES

A Limited Warranty applies to our engineered wood frame with hardwood corner blocks that are used in Albany Industries, Inc product. Albany Industries, Inc warrants the frames to you, the original retail purchaser, to be free of defects in workmanship and materials for 1 year from date of purchase.

This Warranty does not apply to conditions caused by physical damage, improper use or normal wear and tear after the original sale.

CUSHIONING

A Limited Warranty of 1 year applies to all cushions and components used in the seating of all Albany Industries, Inc product. All cushioning will naturally soften with use. This should be considered as normal wear and tear and not as a loss of resiliency or manufacturing defect. This Warranty does not apply to conditions caused by physical damage, improper use or normal wear and tear after the original sale.

SLEEPER MECHANISMS/SLEEPER MATTRESSES

Albany Industries, Inc warrants to you, the original retail purchaser, the sleeper mechanism for 1 year from date of purchase, to be free of defects in workmanship and materials. This Warranty does not apply to conditions caused by physical damage, improper use or normal wear and tear after the original sale

RECLINER/MOTION MECHANISMS

Albany Industries, Inc warrants to you, the original retail purchaser, the recliner/motion mechanism for 1 year from the date of purchase, to be free of material or manufacturing defects. This warranty does not apply to conditions caused by physical damage, improper use or normal wear and tear after the original sale.

CAUTION

Do not allow children to play on this mechanized furniture or operate the mechanism. Leg rest folds down on closing so that a child could possibly be injured. Always leave in an upright and closed position. Keep hands and feet clear of mechanism. Only the occupant should operate it.

SPRINGS

Albany Industries, Inc product has no sag seating construction. Albany Industries, LLC warrants the no sag springs to you, the original retail purchaser, for 1 year from the date of purchase, against spring breakage caused by metal fatigue. This warranty does not apply to conditions caused by physical damage, improper use or normal wear and tear after the original sale.

FABRICS

Albany Industries, Inc warrants to you, the original retail purchaser, for 1 year from date of purchase, all upholstery fabrics against fraying and seam slippage. This warranty is not valid when soiling or abuse is

evident. This warranty also does not apply if there has been a protective coating treatment, spray, or chemical spray after the original shipment to the retailer. This warranty does not apply to conditions caused by physical damage, improper use or normal wear and tear after the original sale.

ALL PRODUCTS

These Limited Warranties are only provided to the original retail purchaser. These Limited Warranties do not apply to any merchandise purchases “as is” or second-hand. No warranty, express or implied, applies to any condition resulting from misuse or abuse, or any condition resulting from incorrect or inadequate maintenance, cleaning or care.

FABRICS

The fabric warranties do not cover any damage or problems with the fabric where there is evidence of soiling, improper cleaning or chemical treatment with any protective coating by the retailer or consumer. Use of such treatments will void all warranties from the fabric mill and Albany Industries, Inc.

CHEMICAL TREATMENTS

These Limited Warranties do not cover damages or defects caused by use of chemical treatments or protective coatings on the finish, leather or upholstered fabric by the original retail purchaser and any such chemical treatments or protective coatings void all warranties of Albany Industries, Inc.

LEATHER, UPHOLSTERED FABRIC AND FINISHES

The Limited Warranties on “Leather”, “Upholstered Fabric” and “Finishes and all Other Furniture Products” do not cover (1) damages resulting from soiling, improper or unapproved cleaning methods, (2) fading or other damages resulting from exposure to sunlight, (3) damages resulting from household humidity, or (4) damages resulting from any liquid, including but not limited to alcohol and water. CAUTION: Any use of improper or unapproved cleaning methods voids all warranties of Albany Industries, Inc.

MODIFICATIONS TO PRODUCTS

These Limited Warranties do not apply to any products that have been altered by any person, dealer, or company without the express written authorization of Albany Industries, Inc.

CAUTION

Motion furniture (recliners, sleeper sofa, etc.) has many moving parts. Caution must be used in operation (opening, closing, etc.). Children should not be allowed to play on or operate motion furniture. Always leave recliners in an upright and closed position and keep hands and feet clear of mechanisms. Only the occupant should operate it. Avoid exposing upholstered furniture to burning cigarettes or cigars, open flames or high temperatures.
